

Miracle Near State Street MIXperience 2009 - Official Contest Rules

Dates/Eligibility. The Miracle Near State Street MIXperience (the "Contest") begins Monday, October 5, 2009, and ends on or about Friday, October 9, 2009. The Contest is open to residents of Illinois, Indiana and Wisconsin ages 18 and over. There is no purchase necessary to enter or win the Contest. Dates and details of the Contest may be revised without prior notice. Any material changes to the Contest will be broadcast on WTMX (FM), THE MIX - 101.9 FM (the "Station"). Winners of a major prize (value \$1,000 or more) in any contests conducted by the Station during or a 60-day period immediately prior to the start of the Contest may not participate.

How to Enter. Each weekday beginning Monday, October 5, 2009, listen to the Station between 7A and 5P. We'll give listeners the chance to qualify (3) three times each weekday at 7:20A, 11:20A and 4:20P. During these times, the Station will invite listeners to call in. Subject to satisfaction of all eligibility requirements, the 10th person to call the Station at 312/591-6800 will receive a pair of tickets to Miracle Near State Street 11 on December 4, 2009, at the Auditorium Theatre. Everyone that wins a pair of tickets will also qualify for the grand prize. One name will be selected at random and announced just before 10A on Friday, October 9, 2009. If the Station is readily able to determine that the caller is ineligible to participate in the Contest, the Station will take the next caller and continue this process until an eligible participant is found. No more than one winner per household. Prizes are non-transferable. Employees or agents of the Station, any entity associated with the sponsorship or conduct of the Contest or any other Chicago area radio station, as well as members of the same household of any such employee or agent, may not participate in the Contest. The Station and sponsors are not responsible for technical, hardware, software or telephone or other transmission failures of any kind; lost or unavailable network connections; or incomplete, garbled or delayed computer transmissions whether caused by the Station, users, by any equipment or programming utilized in promotions, games or contests, or by human error which may occur in the processing of submissions, which may limit a participant's ability to participate.

Prizes. A total of (13) pairs of tickets will be awarded. Each qualifying prize is valued at \$150.

Grand Prize: Friday, December 4, 2009 – A pair of Front Row Tickets to Miracle Near State Street 11 on December 4, 2009, at the Auditorium Theatre, a pair of meet and greet passes to meet The Fray before the show, and an overnight stay in THE MIX Musician Suite at Swissotel Chicago. Conditions/Restrictions. The Station is not responsible for the failure or inability to complete a telephone call, whether due to equipment malfunction, busy lines or otherwise. The telephone number listed above currently does not require an area code from certain Chicago metro area codes. If in doubt, contact your local telephone service provider prior to participating in the Contest. Calling the Station to participate in the Contest constitutes permission for the Station to tape the caller's voice and use it on the air. All telephone calls during the Contest may be taped without further permission from the caller. Each winner will be required to produce identification satisfactory to the Station. Each winner will be required to sign an affidavit of eligibility and release, including a publicity release, as prepared by the Station prior to receiving their prize. All taxes are the responsibility of the prize winner. Winners may be required to complete a W-9 for tax purposes and may receive an IRS Form 1099-Misc. From the date awarded, all forms must be completed, returned and postmarked within 5 days to WTMX-FM.
